## Energy Star New Home Rebate Application



- The City of Newton ENERGY STAR New Home Rebate Program is offering a \$500 rebate to builders who receive an ENERGY STAR certificate for each new single family residential home they build.
- Rebates are only available to qualifying builders who have had a certified HERS rater qualify the home as ENERGY STAR. To find a certified HERS rater in your area, visit the Residential Energy Services Network at [www.natresnet.org](http://www.natresnet.org).
- Rebates are offered on a first-come, first-served basis as funding is available each fiscal year.
- Only new homes with a certificate of occupancy issued on or after 01/01/2009 are eligible for the rebate. The homes must be served by the City of Newton Electric System.

### Checklist:

- Copy of Energy Star Certificate: must have index of 85 or less.
- Copy of Builder W9 form must be on file to process rebate.
- Deadlines: The rebate application form and receipts must be submitted to the City of Newton within six months of completion. Incomplete or incorrect applications must be corrected within 30 days or the applicant will risk losing his/her place in the rebate funding process.
